

Terms and conditions of website use

Introduction

- 1 These terms and conditions govern your use of our website; by using our website, you accept these terms and conditions in full. If you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
- 2 Our website may use cookies. By using our website and agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our privacy policy.

Licence to use website

- 3 Unless otherwise stated, we or our licensors own the intellectual property rights in the website and material on the website. Subject to the licence below, all these intellectual property rights are reserved.
- 4 You may view, download for caching purposes only, and print pages from the website for your own personal use, subject to the restrictions set out below and elsewhere in these terms and conditions.
- 5 You must not:
 - (a) republish material from this website (including republication on another website)
 - (b) sell, rent or sub-license material from the website
 - (c) show any material from the website in public
 - (d) reproduce, duplicate, copy or otherwise exploit material on our website for a commercial purpose
 - (e) edit or otherwise modify any material on the website

Acceptable use

- 21 To the maximum extent permitted by applicable law we exclude all representations, warranties and conditions relating to this website and the use of this website (including, without limitation, any warranties implied by law of satisfactory quality, fitness for purpose and/or the use of reasonable care and skill).

Limitations and exclusions of liability

- 22 Nothing in these terms and conditions will:
 - (a) limit or exclude our or your liability for death or personal injury resulting from negligence;
 - (b) limit or exclude our or your liability for fraud or fraudulent misrepresentation;
 - (c) limit any of our or your liabilities in any way that is not permitted under applicable law; or
 - (d) exclude any of our or your liabilities that may not be excluded under applicable law.
- 24 The limitations and exclusions of liability set out in this Section and elsewhere in these terms and conditions: (a) (b)
 - (a) are subject to the preceding paragraph and
 - (b) govern all liabilities arising under the terms and conditions or in relation to the subject matter of the terms and conditions, including liabilities arising in contract, in tort (including negligence) and for breach of statutory duty.

- 25 To the extent that the website and the information and services on the website are provided free-of-charge, we will not be liable for any loss or damage of any nature.
- 26 We will not be liable to you in respect of any business losses, including (without limitation) loss of or damage to profits, income, revenue, use, production, anticipated savings, business, contracts, commercial opportunities or goodwill.
- 27 We will not be liable to you in respect of any loss or corruption of any data, database or software.
- 28 We will not be liable to you in respect of any special, indirect or consequential loss or damage.

Indemnity

- 29 You hereby indemnify us and undertake to keep us indemnified against any losses, damages, costs, liabilities and expenses (including without limitation legal expenses and any amounts paid by us to a third party in settlement of a claim or dispute on the advice of our legal advisers) incurred or suffered by us arising out of any breach by you of any provision of these terms and conditions, or arising out of any claim that you have breached any provision of these terms and conditions.

Breaches of these terms and conditions

- 30 Without prejudice to our other rights under these terms and conditions, if you breach these terms and conditions in any way, we may take such action as we deem appropriate to deal with the breach, including suspending your access to the website, prohibiting you from accessing the website, blocking computers using your IP address from accessing the website, contacting your internet service provider to request that they block your access to the website and/or bringing court proceedings against you.

Entire agreement
